Anent to Academic Memoranda dated July 21, 2021 and February 7, 2022, where all PCU DILRFI BSA Bridging Program students are required to take the Certification Title Assessments given by the Asia Pacific Professionals Association (APPA), we hereby promulgate additional guidelines and policies, as follows:

- 2. A student is required to take the Certification Title Assessment corresponding to his/her enrolled course. If there are two or more of such Assessments available in a course, at least one (1) assessment must be passed.
- 3. CERTS Educational Services, as an Accredited Training Provider and Business of APPA, is hereby assigned to conduct the training which, in this regard, is already your regular online course training. The training and assessment fees for all the corresponding APPA training and assessments covered during your term of enrollment are free of charge as a privilege to your being a student in the PCU DILRFI BSA Bridging Program.
- 4. A student must be a member of APPA as an Apprentice to take its assessments. To be as such, he/she must do the following:
 - 4.1 Fill out the CERTS Registration Form thru this link https://forms.gle/bZCWuZBfh8uSLAbq7
 - 4.2 Pay the apprenticeship membership to APPA amounting to **P200.00**.
 - 4.3 Register at the www.certsedu.tech for your corresponding Certification Title assessment(s). Kindly ignore the training fees found on the page(s). If your assessment schedule is not yet published, wait for your schedule until February 28, 2022.
- 5. A student is encouraged to avail of this privilege granted only to PCU BSA Bridging students in their presently enrolled courses. Otherwise, a concerned student who so desires to take the APPA Certification Title Assessments while not enrolled in a particular PCU BSA Bridging course would have to pay the regular rate charged by APPA Training Providers.
- 6. Everyone is advised to **claim at least four (4) Certification Titles** from APPA, as additional credentials for graduation.
