TWO (2) SEMESTERS AND ONE (1) SUMMER, EFFECTIVE AY 2025-2026

DATE : July 15, 2025

This is to officially inform you of the following:

1. Effective AY 2025-2026, the PCU BSA Bridging program school calendar will be shifted to the traditional two (2) regular semester terms and one (1) summer term per academic year.

- 2. A regular semester term normally covers 4.5 months while a summer term has a 1.5 months period.

- 4. Accordingly, we will be sending your adjusted Course Mapping within the month of July 2025.
- 5. Your presently enrolled courses will not be changed, except for few old students. As such, for those affected, the tuition schedule for Term 5.3 will also adjust accordingly.
- 6. Term 5.3, AY 2024-2025 will still end on September 30, 2025.
- 7. Your next academic schedule will be Term 6.2, AY 2025-2026 commencing on January 5, 2026. You do not have enrollment and academic activities for Term 6.1 anymore.
- 8. As such, your academic schedule will be free in October, November, and December 2025. In this period, you are guided to do the following:
 - 8.1 Complete, up to December 16, 2025, the possible "INC" course rating in Term 5.3.
 - 8.2 Enroll early for Term 6.2, have an early access, and promptly complete the course requirements, especially for Integrated Accounting Review courses. The early enrollment access starting October 1, 2025 will only be P3,000. This access will end on December 16, 2025. The said early non-refundable access fee is deductible to your tuition in the following term.
- 9. For summer term classes, we will provide you a 2.5-month early access, on top of the 1.5-month summer period access, to complete the course requirements.

Please be guided accordingly.
