#### I. Purpose

To ensure academic integrity, proper student validation, and compliance with institutional approval processes before students take examinations through the Computer-Assisted Academic and Assessment Reporting and Testing System (CAARTS).

## II. Policy Statement

All students enrolled in the following programs under the College of Business Administration and Accountancy (CBAA) are required to secure endorsement and approval prior to taking any examination through CAARTS:

- Bachelor of Science in Accountancy (BSA)
- Bachelor of Science in Customs Administration (BSCA)
- Bachelor of Science in Real Estate Management (BSREM)

#### III. Procedural Guidelines

#### 1. Endorsement by the Program Head

- The Program Head, through the Program Secretaries, shall review the student's compliance with academic and administrative requirements (e.g., attendance, submission of coursework, and payment validation).
- o Only students in good standing shall be endorsed for examination.

#### 2. Approval by the Dean, CBAA

- The endorsement must be forwarded to the Office of the Dean for final approval.
- The Dean shall verify the list of endorsed students prior to examination scheduling in CAARTS.

#### 3. Submission to CAARTS Administrator

- The approved list shall be submitted to the CAARTS Administrator at least three (3) working days before the scheduled examination
- No student will be allowed to take the exam without both the Program Head's endorsement and Dean's approval.

## 4. Monitoring and Compliance:

- The CBAA QA Office shall periodically review compliance with this policy and recommend corrective measures for any lapses.
- Unauthorized access or participation in CAARTS examinations without proper endorsement shall be subject to administrative sanction.

## VI. Effectivity:

This policy shall take effect immediately upon approval and dissemination to all program heads, faculty members, and students within the College of Business Administration and Accountancy.
